

u. To take up all any constructional development activity programmes under various developments that involve poor labor and rural employment programmes to develop Rural poor.

v. To create awareness in health development human resources, consumer activity among the people with a particular eye on rural uneducated men and women and children.

w. To create and foster a general interest in education among the scheduled castes and on particular to give them special facilities, scholarships and Free-ships for higher education. To promote science, literature and fine arts and to impart useful knowledge.

5. TRUSTEES TO RENDER TRUE ACCOUNTS: -

The trustees shall cause true and accurate accounts to be kept of all moneys received and spent and all materials in respect thereof in the course of management of trust fund or in relation to carrying out the objects and purposes of the trust as well as assets, credits and efforts of the trust.

6. POWERS OF THE TRUSTEES: -

For the furtherance of the objects, i.e., for service to the community in general and to the poor and weaker sections and as mentioned in clause 4 the trustees will have the following, which will be exercised by them:

- To accept any donation, contributions, grant or subscriptions in cash or in kind from any person, body of persons or trust.
- To apply the whole or part of the income of the trust or accumulation thereof in whole or part of the corpus of the trust fund for any one or more of the objects of the trust as the trustees may, in their description from time to time, determine.

- c) To convert and deal with investments comprised in the trust fund and/or to carry the investment for the time being in the modes prescribed u/s.11 (5) of the I.T.Act, 1961.
- d) To invest and keep invested the trust fund either in the purchase or mortgage of immovable property including a flat or in units, shares, stocks, or debentures permitted by the Indian Trust Act, 1882 or any other statute, or deposit with banks, firms and to alter, vary or transfer such investments from time to time as the trustees may in their discretions think fit for others of the same or different nature.
- e) To borrow or rise or secure payment of money and also lend money either with or without security at the discretion of the trustees.
- f) To let out premises any immovable property of the trust for such period and at such rent and on such terms and conditions as the trustees in their discretions may think fit.
- g) To open accounts in the name of trust with any Scheduled or Co-operative, Nationalized, Private Financial Institution or Bank, operate such accounts and to give instructions to the banks and to provide for the opening and operation of such accounts by Managing Trustee of the Trust.
- h) To appoint constituted attorneys or agents and delegate to such attorneys or agents and delegate to such attorneys or agents all or any of the powers vested in them under these presents and from time to time remove such attorneys or agents and appoint other or others in his/her or their place.
- i) To appoint or make provisions for the appointment of any person (including all or any of the trustees) as a committee of administrators or Managing Trustee or otherwise for the purpose of the administration of the trust in such manner and subject to such rules and regulations as the trustees may prescribed and also to appoint or provide for the appointment of separate trustees to hold any property or any funds or investment, subject to the provisions of this Deed, in such manner and subject to such rules and regulations as the trustees may from time to time think fit.
