2. Government Notification No. ED 137 Miscellaneous 98, to have within 2 months of obtaining permission under Section 36 308 39 6 òr m 2 131 22 98. ಂ, ಲಾ: 04-11-99 09 9 98 as per Karnataka Education Act 1983 (Act 1 of 1995). Bangalore, Dated : 19-05-09, application shall be made to the competent authorities and the security deposit prescribed by the institution for starting the school as prescribed in Government Notification No.: ED.369 PGC 2014, 1908: 11.11.2014 and related amendment order shall be submitted to the Accreditation Renewal Authority and the Secretaries of the Governing Body. To be kept in joint account.
13. Government Notification No. : ED. 52 miscellaneous 99 Dated 02-02-2000 Annexure-5 As per the rules the ratio of pupils to teachers shall be observed in every class permitted.
14. BED trained teachers should be recruited from class 6 to class 8.

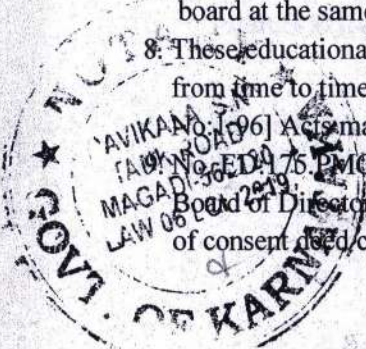

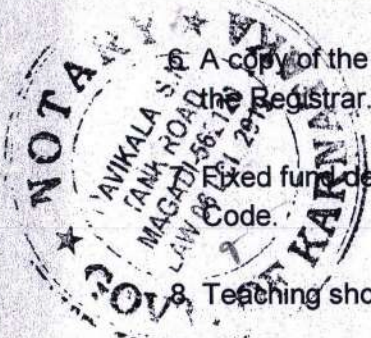



7. Fixed fund deposit should be kept in joint name as per rules of Karnataka Education Code.
8. Teaching should be done only in permitted media.
9. Submission of list of Governing Body members approved by the Registrar.



10. Compulsory provision of service security and mandatory compliance of service conditions to the teachers performing duty in the school.
11. Regarding school safety, fire extinguishers should be installed.
12. Teachers should be paid through bank account .
13. Provision of separate toilets for boys/girls in the school .
14. The accreditation has been renewed for this year on the condition that the number of children is less than the minimum for the current year. Note that renewal of accreditation will automatically be canceled if the provision is not complied with.
